Multiple infringements in KL's back lanes The Star Exclusive

DBKL enforcement team identifies several hotspots, including Brickfields

OWNERS of commercial shops in Kuala Lumpur who have installed unauthorised extensions and structures on their premises will be given a grace period to take them down or face enforcement

Following numerous complaints from agencies like waste regulator Solid Waste Management and Public Cleansing Corporation (SWCorp), waste company Alam Flora and LA21 secretariat, Kuala Lumpur City Hall (DBKL) issued

notices to business owners who carried out extensions or built structures to their properties without approval.

StarMetro learned that SWCorp received numerous complaints from Alam Flora on difficulties faced in cleaning drains due to the obstructions by the eateries.

As a result, DBKL issued warn-

ing notices ordering owners to demolish the extensions or face the consequence.

An enforcement team has identified several hotspots in the city and Brickfields is one of the areas. The area identified is the back

alley of Jalan Thambipillay where officers found multiple infringe-

Shoplots, especially restaurants, have fixed grilles, built steps over drains, installed exhaust fans and sinks that take up a huge portion of the road and obstruct traffic.

Alam Flora contractors constantly complain about facing difficulties in gaining access to back roads due to these obstacles which affect their productivity.


A DBKL enforcement officer, who preferred anonymity, said all building owners had been notified about the demolition exercise.

"A meeting was held recently to prepare for the operation before a date is locked down for the demolition exercise.

They (business owners) have been warned and we would prefer if they remove the extensions themselves, but we are not tolerating this (illegal extensions) any longer," he said.

Local Agenda 21 secretariat and coordinator A. Ghani Mohamed hoped that in the future DBKL would incorporate into its standard operating procedure (rules regarding application for licences) to ensure there were no infringe-

IT LOOKS like it is the end of the road for Ali Cafe Tomyam Seafood restaurant at Jalan Pantai Baru in Bangsar as the Federal Territories Land and Mines Office (PPTGWP) has agreed for it to be demolished by the end of February.

The popular eatery which has dodged several attempts by the authorities to demolish it in the past decade, despite being illegally built on government land, has finally run out of luck.

A Kuala Lumpur City Hall spokesman told StarMetro that the decision was made at a post cabinet meeting recently.

The spokesman said Áli Cafe Tomyam's operating licence had expired and DBKL was waiting for the temporary licence of another stall, operating nearby, to expire before demolishing both struc-

An enforcement officer from DBKL said a demolition exercise was planned a few years ago but it was halted at the eleventh

The officer said they were ordered to leave the scene and DBKL's Licensing Department was instructed to ensure that the eatery's licence was approved no matter what.

Last year, Federal Territories Minister, Khalid Abdul Samad highlighted cases involving illegal buildings built on government-owned spaces during the previous government's adminis-

Ali Cafe started off as a small stall under a tree 20 years ago and throughout the years gained

popularity resulting in the owner, Ali Syed Mohamed, extending the stall into a double-storey build-

Ali told *StarMetro* last year that he spent RM3mil to upgrade the place after getting the go-ahead from a high-ranking government official even though it was not approved by PPTGWP.

The restaurant came under fire as it is built on a road divider, occupying several parking bays.

The building is located next to the Pantai fire station, prompting more questions as to its legality.

Last year, the PPTGWP issued a notice under Section 425 (1) of the National Land Code 1965, for occupying government land illegally and were told to vacate

the premises.

If the owners fail to move out, they can be fined up RM500,000 or jailed for not more than five

The DBKL spokesman said that

the local authority was going on a blitz to demolish illegal structures in the city, and it needed to set an

"We cannot be telling people to demolish their illegal structures

but yet allow some people to get away with it," the spokesperson added.

"To those who have put up illegal structures, my advice is remove it or we will do it."

grease traps and operators who carry out illegal extensions should not be allowed to have their business licences renewed when it

That way, those who have broken the rules can rectify their mistake by dismantling the illegal structures so they can get their licence renewed," Ghani said.

StarMetro took a stroll along the city's back lanes and found hundreds of infringements in all man-

The illegal structures were indirectly or directly causing the drains to be clogged with gunk from fat, oil and grease as it was getting increasingly difficult to clean the drains.

There are many areas including Bangsar, Plaza Damansara and Sri Petaling where communities complained of illegal extensions, clogged drains and lack of grease traps by commercial units which have not been addressed by the authorities.

We saw drains that were cemented over and obstructions placed on them making it difficult

for utility and waste companies to carry out cleansing work.

Some establishments like hotels even constructed steps at the back, while it was common to see caged compartments for gas tanks built by restaurants which are obstruc-

tions that take up space. Even the illegally installed exhaust fans not done according to specification were seen.

In some places the fans were spewing water directly into the drains and messing up the area.
